## 2019-2020 SCHOOL YEAR BEHIND THE WHEEL(BTW) REGISTRATION

**COST IS \$20.00** (TWENTY DOLLARS)

**ELIGIBILITY REQUIREMENTS:**

1. Student must have completed the classroom portion of Driver's Education.
2. Student must have a valid Virginia learner's permit to enroll in the BTW course.
3. Parents are responsible for transporting their children to the Phoebus High School driving range. They must also provide a certificate of completion (green card) from the Drivers Education class.
4. Registration should be received in our office at least one week prior to the start of each session.
5. A non-refundable payment by money order/cashier's check for **\$20.00** should be sent with registration.
6. The same policies and guidelines found in the Students Rights and Responsibilities Handbook enforced during regular school hours shall be enforced. Inappropriate behavior shall result in the student being sent home and rescheduled another time. **SECOND OFFENSE SHALL RESULT IN REMOVAL FROM COURSE WITHOUT REFUND.**
7. In order for a student to gain driving privileges after completion of BTW, the student must:
  - a. Be at least 16 years old and 3 months & have held their learner's permit for nine (9) months.
  - b. Complete the in-car, 14 hours, BTW instruction, the 45-hour driving log with a parent/guardian, and submit the completed driving log to the BTW instructor if student is under 18 years old.
  - c. A parent/guardian must be present to sign the 180-Day Provisional Driver's License on the last BTW day. Paperwork will be forwarded for a court appearance in which the student will receive a permanent license. (Court date is mailed to the address on your learner's permit.)
