#### Introduction

On October 24, 2022, Governor Glenn Youngkin and state education leaders presented to the public a <u>summary</u> of the 2022 National Assessment of Education Progress data for Virginia. The data indicate that Virginia had the most significant declines in reading and mathematics in the nation. <u>Our Commitment to Virginia's Children</u> is a seven step action plan to reverse the downward path of declining achievement and ensure that all children in Virginia have the tools and support structure to get back on track.

In Action Seven of the action plan, Governor Youngkin challenges school divisions to spend all of their remaining Elementary and Secondary School Emergency Relief (ESSER) funds on proven efforts to recover learning like: supplementing learning through instruction before school, after school, on weekends, and in the summer; providing direct support to families to access tutoring; extending the school year; and rewarding those teachers and schools that make the greatest impact on student learning with performance bonuses. Action Seven also directs the State Superintendent of Public Instruction to require all school divisions to reengage the public in consultation and to update their American Rescue Plan (ARP) ESSER spending plans, as initially required by federal regulation, by December 31, 2022.

A. Describe how the LEA identified learning loss, including among student groups most likely to have experienced the impact of lost instructional time such as students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students

Prior to the pandemic, Hampton City Schools (HCS) created a robust and comprehensive data system to track and monitor a variety of academic and nonacademic data points at the following levels: a) division, b) school, c) student group, and d) individual student. This system has proven to be invaluable throughout the pandemic, allowing internal

stakeholders access to performance data for instructional decision-making purposes. For example, division/school leaders and classroom teachers are able to easily identify students in the primary grades who have demonstrated learning loss in the area of literacy. As a result, resources have been allocated and structures put in place to address the specific learning needs of select student groups (i.e., students with disabilities) as well as individual students. This data system has enabled HCS to be strategic in its use of human and fiscal resources; current data indicate that interventions have resulted in student academic progress. For example, when comparing the performance of HCS students on spring 2022 Virginia Standards of Learning (SOL) assessments to students in surrounding divisions with similar demographics, HCS student achievement data is trending in a positive direction and gaps in learning are being closed when compared to pre-pandemic student performance. B. Provide a detailed description of how the LEA used or will use the funds it reserves to implement evidence-based interventions to address learning loss

External Tutors - The division entered into a partnership with FEV Tutor. This company provides a comprehensive one-to-one online tutoring service to students in grades 3-12. Students are able to access this service 24 hours a day, seven days a week throughout the school year either through on-demand tutoring sessions or by scheduling recurring sessions. One realized benefit of this tutoring service has been that students are able to receive differentiated support to meet their individual student needs. For example, students are able to upload homework assignments to a tutor and indicate which specific math problems pose a challenge. The tutor is then able to assist students in working through these specific problems. FEV Tutor also offers a comprehensive translation component that allows students whose primary language is one other than English to access the service. Additionally, HCS is pleased to report that all students in the school division either have high speed internet in their homes or have been provided access to high speed internet through either the school division's partnership with Cox Communications or distribution of portable MiFi devices.

Learning Recovery Facilitators - The division has hired 22 Learning Recovery Facilitators. As noted in this job posting, the primary role of these individuals is to provide support to elementary and secondary school students in the areas of English, mathematics, and science through groups or targeted support to address student learning needs in these content areas. Many of the individuals hired for these positions have an area of expertise in one or more of these content areas. For example, a former engineer is assigned to select high school students to provide small group instruction in the area of mathematics, while a former science teacher is conducting science labs in various elementary schools.

**Secondary Arts and Literacy Program** - The Secondary Arts and Literacy Program builds student knowledge and skill development in visual and performing arts for grades 6-12. The program uses language arts with drama, music (band, chorus, and guitar), and

visual art. Each subject will use the current beginning, intermediate, and advanced curriculum to scaffold skills and motivate students that missed fundamental training in these subjects resulting in learning and performance/production loss.

- Two eight-day summer programs
- All secondary schools
- Subjects include: Language Arts/Drama, Band, Chorus, Guitar, Visual Art
- Guest clinicians and master class presenters
- Innovative resources

Over two summers, schools will provide opportunities for students to reinforce the visual and performing arts curriculum using direct reading and writing connections.

**Digital Instructional Resources** - HCS has used federal funds to purchase a variety of digital instructional resources. In addition to complementing the HCS curriculum, these resources support teachers' student intervention and remediation efforts.

- Literacy Pro This resource was purchased for Grades K-8. Grades 2-8 students use this digital platform to take their Reading Measure assessments three to four times a year to measure reading growth. The division also utilizes this resource to help facilitate independent reading groups; the platform provides a variety of digital and audio books as well as reading comprehension assessments.
- **StudySync** -This resource is embedded into the HCS English curriculum for students in grades 6-8. It is used for shared reading, independent reading and assigned student work. StudySync provides digital texts, graphic organizers, and comprehension response questions.
- **Benchmark Education Company** The Benchmark resource is utilized in grades K-5. This platform provides teacher resources, curriculum, materials, and digital books for students. The resources are embedded into the division's K-5 curriculum.
- Rhymes with Reason This digital resource is utilized in the division's Reading and Writing Exploration class in select secondary schools. This class focuses on remediation in reading and writing for select middle and high school students who are demonstrating deficiencies in English Language Arts. This program provides an engaging audio experience that increases students' vocabulary knowledge during small group instructional rotations.
- Read 180 This resource includes both a digital platform and consumable workbooks that are utilized in the division's high school Literacy Acceleration classes. The Read 180 program also includes a Reading Inventory Assessment that is administered periodically to measure student growth in the area of reading comprehension.
- **Discovery Education** This platform is a digital textbook designed for students and teachers in grades K-12. It contains resources that help to facilitate learning via multiple modalities. For example, students and teachers are able to access interactive lessons, lessons aligned with the Virginia Department of Education Standards of Learning, interactive science labs, Assessment Builders for teachers to support

- student testing, remediation and spiraling lessons, as well as supplemental resources that relate to real world applications.
- Screencastify This resource was purchased for all HCS staff and students. Teachers use the platform to make short instructional videos for students that can be embedded into synchronous and asynchronous lessons. Information technology and digital learning specialists use this resource to create screencasts that help students and teachers use new platforms or troubleshoot issues with existing ones. Students are able to use Screencastify as well to create videos for school assignments.
- Reading A to Z- This resource provides teacher licenses for individuals educating our significant cognitive disabled students. It provide online leveled readers to support literacy and content instruction for students in grades K-12. Teachers can access decodable text, as well as nonfiction and fiction selections with matched comprehension activities.
- Gale in Context Middle School Gale in Context Middle School is a database of content with age-appropriate videos, newspapers, magazines, primary sources, and much more. Categories cover a range of the most-studied topics including cultures, government, people, U.S. and world history, literature, and many more. Teachers use these resources to supplement instruction. Students use these resources to extend their learning, research topics of interest, and complete assignments.
- National Geographic This resource is a database of 653 National Geographic eBooks, 3000+ Nat Geo magazines, and 218 videos. Teachers use these resources to supplement instruction. Students use these resources to extend their learning, research topics of interest, and complete assignments.
- MakeMusic -The Make Music platform uses Smart Music. Smart Music is a web-based suite of music education tools and has the largest interactive and digital music libraries for music education. Students use the tools to practice with recordings of their individual parts and perform with full professional ensemble recordings. Students use the sight-read feature to develop their music-reading literacy skills. Teachers use the platform's scoring features and custom rubrics. Teachers and students use the tuner, metronome, fingering charts, and looping capability to record and receive immediate feedback.

Early Reading Intervention Instructional Assistants - We have 47 Early Reading Intervention Instructional Assistants that work with students in Grades K-3 (7 are funded using ARP ESSER grant). These students are identified using the PALS (Phonological Awareness Literacy Screening) platform. Students identified must receive instruction either through a program or with personnel trained to use a phonics based lesson. Our ERIA's utilize the SIPPS (Systematic Instruction in Phoneme Awareness, Phonics, and Sight Words) program for 30 minutes daily with identified students.

**University Corner** - University Corner serves 14 Elementary Schools and over 560 students daily. University Corner targets Tier III and Tier II students to provide additional

academic support. In addition, students receive tutoring, enrichment, and field trips that help reinforce school-day learning.

**Student Books/Texts/Literacy Kits** - Several resources have been purchased to support small group instruction in elementary school. A variety of Decodables readers have been provided to teachers. Some of these Decodable brands are Flyleaf, ISME (Institute for Multi-Sensory Education), and Alphabet Series. We have also purchased a phonics guide, Recipe for Reading.

**Substitute compensation to increase fill rates** - Substitute pay rates have been adjusted multiple times to attract additional substitute teachers and instructional assistants. The increased rates allow the division to be more competitive with other local school divisions who are also looking for an increased number of substitutes.

C. Describe how the LEA produces evidence of the effectiveness of evidence-based learning loss interventions employed

Hampton City Schools (HCS) has created two comprehensive tools for tracking and monitoring student achievement progress. The first tool is called the *HCS Response to Intervention Database*, and the second tool is the *Student Achievement Game Plan* website. Both of these data tools are used to assist school administrators and division leaders in determining the effectiveness of evidence-based interventions, particularly in the areas of reading and mathematics.

The HCS Response to Intervention Database houses a variety of student data points that are monitored by the school division. For example, the database contains detailed information regarding baseline data and student performance in the area of early literacy. School division leaders, school administrators, and teachers, are able to view individual student literacy profiles in this database and run reports at the school, classroom, and individual student level. Kindergarten teachers, for example, use the database in their grade level meetings to monitor such data points throughout the year as letter recognition and students' ability to sound out letters. Additionally, middle school English teachers use this database to hold individual conversations with their students regarding progress on the Scholastic Reading Measure (SRM) assessment. This reading comprehension assessment, which is administered three times during the school year to students in grades 3 through 8, helps schools to determine whether students are meeting grade level expectations in the area of reading comprehension and whether interventions are closing gaps in reading. Data from these assessments are used by teachers to plan for their small group reading lessons and by school leaders to monitor learning loss and reading progress. The HCS Response to Intervention Database houses a variety of other data points (i.e., progress in the area of math and science) as well as logs interventions that are being implemented throughout the school year.

The second data tool that the division uses to monitor learning loss and student academic progress is the Student Achievement Game Plan website. This website, created by school division leaders, is an internal website accessible to division leaders and school

administrators. It houses a variety of academic and non-academic data. For example, school division leaders and school administrators are able to monitor and access reports related to student attendance, student discipline, as well as progress in the area of all core academic subjects (i.e., reading, writing, mathematics, science, and social studies). Student Performance by Question (SPBQ) reports within this site are one strategy used by administrators to identify specific skills that represent areas of strength and growth. For example, HCS administers tests at the end of the first three grading periods to students in grades 2 through 8, as well as high school, to determine student mastery of select skills and knowledge items that were taught during the quarter. The SPBQ reports allow principals to view this data presented in a way where it can be used to have individual conversations with teachers regarding student performance on these assessments to determine where remediation is needed for select students with select skills and if interventions are resulting in academic progress.

#### **Section 6: Other Uses of Funds**

HCS implemented a sign-on bonus for positions that are hard to staff (e.g., teachers, bus drivers, school counselors, therapists). Additionally, the funds will be used to cover the cost of a Federal Pandemic Relief Bonus for non-SOQ (Standards of Quality) positions which were not covered in the funding received from the state for the SOQ positions.

  - 9 Support Staff, 7 Early Reading Instruction Assistants, and 22 Learning Recovery Facilitators

The majority of the grant funded positions will be retained through natural occurring vacancies. Positions that are determined to be needed beyond the grant will be retained through budget reductions and/or additional local or state if available to fund the positions.

B. Describe the extent to which the LEA used or will use ARP ESSER funds to implement prevention and mitigation strategies in order to continuously and safely operate schools for inperson learning

Funds were allocated to purchase and replace sanitization supplies (e.g., disinfectant spray, wipes, and filter replacements).

Funds were allocated and used to replace 41 buses (currently over 15 years old) with Air Conditioning and HEPA Air filtration (with replacement filters) to improve the air quality on buses.

C. If the LEA used or will use ARP ESSER funds for HVAC, renovation, or other capital projects, describe each project, including whether the LEAs has requested and received <u>approval</u> for the project

HVAC projects, to improve the air quality within buildings and meet ASHRAE standards, were submitted and approved by the Virginia Department of Education for the following schools: Langley Elementary, Forrest Elementary, Asbury Elementary, Machen Elementary, Mallory, Mary S. Peake Elementary, and Smith Elementary.

Additionally, these new HVAC systems will allow all areas of the school building to be conditioned space, thus making it suitable for various instructional usages and allowing for greater social distancing.

Roof (and roof façade) replacement projects, to repair leaks that impact air quality within buildings, were submitted and approved by the Virginia Department of Education for the following schools: Burbank Elementary, Tarrant Middle, Asbury Elementary, Bethel High, Eaton Middle, Hampton High, Kilgore Gifted Center, Merrimack, and Patriot Operations Center.

Other uses of funds include the following: Student Chromebooks, teacher laptops, food for meal kits for virtual students, zoom license, van for Title I schools, and indirect costs.

In the area of social, emotional, and mental health needs for students and staff, funds have been used and allocated for the following: Care Solace, Student Engagement

Specialist, Enrollment/Attendance Specialist, services from Communities in School, Threat Assessment Lead and Restorative Practice Lead supplements, Panorama social emotional screener, Critical Incident Stress Management training, Student Achievement Assessment supplement, Restorative Justice Model consultant, Early Childhood Student Engagement Specialist, and a partnership with the local Community Service Board.





#### Q3 Which school level are you currently enrolled in?






